We will also be accepting but limiting food vendors, vintage and boutique clothing, and jewelry. No multi level marketing companies will be accepted.

## Information/Rules/Regulations

- Vendors will supply their own items needed to stage their space. Canopies
  are permitted for those not under cover, but with weights only. "No stakes!"
  White canopies are preferred but it can be any color. The use of tables and
  chairs are accepted if used in a manner which allows a space to be staged
  appropriately for an upscale event.
- Spaces are 10x10 undercover at \$250 each (limited spaces available), 10x10 open air \$200 each, and 10x10 food vendor \$200 each (appropriate steps will be taken to accommodate large equipment including trucks, trailers, smokers, etc.). Electricity is available for \$35. You must include full payment with the contract which can be made on our website.
- You may not sublease your space to anyone else. There is no sharing of a booth. The only people allowed to sell or display in your area are those whose names are shown on the contract. We ask that no one leave their space unattended. If you need to use the bathroom or grab food, please ask someone to watch your booth for you. Vendors are required to leave their space the same as when they arrived. It will be necessary to remove all items by end of move out. Tear down may not start until the end of the event. Remove all trash! This is a beautiful venue that people enjoy on a regular

basis and we want to respect it. A fee may apply if a vendors space is not properly cleaned.

- Vendors submit liability insurance, licensing, and/or certification if available and/or applicable.
- Non-Smoking Facility, No Alcoholic Beverages Allowed
- Decorations need approval prior to attaching to any surface. No confetti or glitter is allowed. Permanent graphics, signs, advertisements or displays cannot be blocked in any manner, nor temporary signs or decorations be attached to permanent building graphics. Planters and furniture in public areas, galleries, ramp ways, etc. may not be removed or repositioned.
- Animals and pets are not permitted. Service animals are permitted.
- No handguns concealed or otherwise or other weapons are permitted.
- No speeding or reckless use of vehicles or equipment will be permitted.
- No gasoline, kerosene, diesel fuel or other flammable liquids may be stored, permanently or temporarily, in hazardous work areas and/or public areas.
- Cables, hoses, etc. must be covered for the safety of the public, workers, vendors, etc.
- Overnight parking is strictly prohibited. Camping is available and vendors should contact South Florida Fairgrounds security for details. Fees Apply.
- All parties must comply with all federal, state, and municipal fire codes which apply to places of public assembly.
- Ruffles and Overalls reserves the right to cancel the event for economic reasons, public good, or events including, but not limited to acts of God, fire, flood, natural disaster, a threat of a tropical storm/hurricane, inclement weather, war or threat of war, acts or threats of terrorism, civil disorder, unauthorized strikes, governmental regulation or advisory, recognized health threats as determined by the World Health Organization, the Centers for Disease Control, or local government authority or health agencies, a pandemic, a curtailment of transportation facilities, or other similar occurrence beyond the control of the parties in which case any funds paid by the vendor for unused days, less actual expenses necessarily incurred by the Vintage Roots Market in connection with the Event so cancelled, will be refunded without penalty. Should Ruffles and Overalls exercise its rights to

cancel the Vintage Roots Market for any reason, including but not limited to those stated above, Vendor agrees to forego any and all claims for damages against Ruffles and Overalls and further agrees to waive any and all rights which might arise by reason of the terms of this contract and the vendor shall have no recourse of any kind against Ruffles and Overalls, its owners, agents, and employees.

- Vendor assumes all responsibility for all goods, materials, exhibits, displays, articles and other tangible personal property in or on the Vintage Roots Market event/ Yesteryear Village property before, during, or after the event and Ruffles and Overalls assumes no responsibility for said items.
- Vintage Roots Market is not in any way responsible for the sale or purchase
  of items. Vintage Roots Market is not responsible to enforce the terms of any
  sales transactions between the vendors and customers who participate in the
  Vintage Roots Market. The vendor is solely responsible for any and all sales
  tax.
